SPOT AUCTION PUBLIC NOTICE


It is hereby notified to the General Public that auction for removal of trees fallen in Sadar Bazar, Ahmedabad Cantt due of cyclone will be held on 02/08/2021 at 1200 hrs. in the office of Cantonment Board Office, Ahmedabad, Gujarat on following terms & conditions.

TERMS AND CONDITIONS

1. All the intending bidders are required to deposit Rs. 1000/- (Rupees One Thousand Only) as earnest money. Nobody shall be permitted to participate in the auction without deposit of EMD.
2. EMD of unsuccessful bidders shall be refunded after the auction.
3. Successful bidder shall be required to deposit full amount of bid immediately after completion of auction & his declaration as successful bidder.
4. The bid will be subject to confirmation of the Cantonment Board which is at liberty to Accept/ reject the highest or any bid without assigning any reasons thereof. Decision of Board shall be final & binding on all the parties.
5. Successful bidders shall remove only such trees/ branches as per directed by the CEO or his authorized representative.
6. The successful bidder shall have to remove all the trees/ branches (as per Clause 5 above) within 10 days of acceptance of bid.
7. The successful bidder shall not cause any damage what-so-ever while removing the trees/ branches & in the event of causing any damage, he shall be required to compensate the loss as assessed by CEO.
8. The date & time of auction can be postponed as per direction of CEO.
9. The bidder should not have any Cantonment board's dues for which he/she has to submit no dues certificate before start of auction.
10. The bidders have to submit 02 passport size photographs and proof of residential / postal address.
11. Board reserves right to cancel the auction at any stage.
