As per the schedule, written examination for recruitment of SI in the permanent establishment of Ahmedabad Cantt. Board, was conducted under the supervision of committee constituted by PCB. Total 205 nos. of candidates participated in the written examination. At the end of written examination held on 28-08-2022, the examination committee submitted score of 205 candidates and committee shortlisted top 15 candidates based on marks in the written examination. Ahmedabad Cantonment Board published the score of 205 candidates alongwith list of candidates shortlisted for skill test, on official website of Ahmedabad Cantonment Board on 28-08-2022. Hall Tickets for the Skill Test conducted on 30-08-2022 in respect of short listed candidates were forwarded on the email address, by Ahmedabad Cantt. Board .


The shortlisted candidates were required to appear for the skill test scheduled on 30-08-2022. Out of 15 shortlisted candidates, 14 candidates appeared for skill test held on 30-08-2022 at Dr.Baba Saheb Ambedkar Open University, Ahmedabad and the Skill Test was conducted by Dr.Baba Saheb Ambedkar Open University, Ahmedabad under the supervision of committee constituted by the PCB.

Resolution no.1 : Recruitment of Sanitary Inspector in permanent establishment of Ahmedabad Cantonment Board

Considered and approved. After a brief discussion the Board unanimously appreciated the transparency and smooth conduct of subject examination by all the stake holders.

Board noted the performance of top four candidates who have scored highest marks in combined score of written and skill test is as under :-

Board was of the opinion that two rankers gained the same score i.e. 120 but decided that the candidate who scored the highest score in written test out of the two candidates should be given the upper rank from amongst the two.

Board further resolved to authorise the CEO to issue offer letter to the candidate who scored 1st rank in the combined score of the subject examination i.e. Shri Vijay Vitthalbhai Makwana on a probation of two years from date of joining the service on the supervisory post of Sanitary Inspector in the permanent establishment of Ahmedabad Cantonment Board. Board also resolved that the names of another 3 rankers should be kept in waiting for a period of six months in case if the selected candidate is unwilling to join or he leaves / quits the job within six months of resuming his duty.

Board further resolved that the candidate appointed on post of SI should be kept under training for a period of two months under the retired SI who is hired on contractual basis by the Board and thereafter he should be allowed to handle the charge of Sanitary Inspector.
