The Bye-laws for Regulating the Inspection and the giving of fees of Cantonment records and documents in the Ahmedabad Cantonment in Ahmedabad Cantonment which the Ahmedabad Cantonment Board proposes to ammend in exercise of the powers conferred by sub-section (1) and (2) of Section 350 of the Cantonments Act 2006, the Central Government is hereby pleased to approve and confirm with Bye-laws for Regulating the Inspection and the giving of fees of Cantonment records and documents in the Ahmedabad Cantonment is hereby published, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft regulations will be taken into consideration by Cantonment Board, Ahmedabad after the expiry of thirty days from the date of publication of this notice.

2 Any objections or suggestions which may be received from any person with respect to the said draft before the expiry of the period of thirty days stated above will be considered by the Ahmedabad Cantonment Board.

3 Detailed Bye laws regarding Byelaws for Regulating the Inspection and the giving of fees of Cantonment records and documents in the Ahmedabad Cantonment has been uploaded on Ahmedabad Cantonment Board website ahmedabad.cantt.gov.in and placed on the Office Notice Board for perusal of the public.

4. Any person who intends to file objections/suggestions in respect of the Byelaws for Regulating the Inspection and the giving of fees of Cantonment records and documents in the Ahmedabad Cantonment may submit the same in the **Office of the Cantonment Board Ahmedabad, nr Camp Hanuman Temple, Shahibaug, Ahmedabad-04** in person or through dak or by email on ceoahmeda-stats@nic.in on or before the expiry of a period of thirty days from the date of publication of this notice.

**BYE-LAWS FOR REGULATING THE INSPECTION AND THE GIVING OF FEES OF
CANTONMENT RECORDS AND DOCUMENTS IN THE AHMEDABAD CANTONMENT**

Except as otherwise provided by or under the Cantonments Act, 2006 or by any other law for the time being in force, or as hereafter provided, no copy of the extract from any register, book, accounts, record or documents belonging to or in the possession of the Cantonment Board shall be given nor shall inspection of any of the Cantonment Board shall be given nor shall inspection of any such register, book, accounts record or document be granted to any person without the previous sanction in writing of the Chief Executive Officer.

2. Except as aforesaid, every person wishing to inspect such record or document or to obtain any copy thereof or extract thereon shall apply in writing to the Chief Executive Officer stating clearly and correctly the description of such record or document.

3. No admission shall be given for the inspection of any correspondence between the Board and the Government or any officer of the Government of any other document, the inspection of which is, in the opinion of the President, Cantonment Board, detrimental to the interest of the Board or of the Government to the inspection of which the party applying is not entitled to, nor shall, copies of or extracts from any such correspondence or documents be supplied.

4. No copy shall be granted of a record, map or plan which has been printed or lithographed and published under the authority of the Government of India and is for sale to the general public.

5. No extracts from documents shall be given which when read apart from the context is capable of misrepresenting the purpose or any final order passed by the Board or any officer of the Board.

6. The following fees shall be charged and credited in advance to the Cantonment funds.

- (i) For inspection of any document or record other than a minutes book, Rs.500/- for hour or part thereof.
- (ii) For a certified copy of a map or plan or any portion of a map or plan of any immoveable property bearing a separate survey number, Rs.1,000/-.
- (iii) For the supply of a duplicate copy of the license – Rs.500/-.
- (iv) For the supply of any other document not covered by the above – Rs.10/- for per page or part of a page of the register, as the case may be.

7. No permission for inspection or for copy or extract will be granted unless payment is received in advance through the prescribed mode of payment as Board may deem fit.
